# Wastewater Report - Administrator Brigid Forlenza

1. I.A.I Reports – Reports are included in the packets.

During the month of October 2024 approximately 9,137,000 gallons of wastewater were generated to Elkhart. The collection system continues to operate in excellent condition. Discussion followed. Routine maintenance has been completed and Bioxide has been delivered.

# 2. Wastewater Report

- We continue to wait on new parts to repair the Bypass Pump.
- Received quote from CT Electric for a down-looker needed for C1 lift station. Will be discussed in New Business #2.
- Sanitary wet well lining still pending.
- Shed and testing equipment has been ordered. Remaining details to complete the lot project are in progress.

#### **Unfinished - Old Business**

1. South Shore Drive – Property in question will be restored to its original state during the month of December 2024.

#### **New Business**

1. Testing Shed – Base A budget is included in the packet from Selge Construction to pour a slab (includes the equipment room) for the shed. Included in the budget is mobilization, excavation of shed slab, piping for new equipment and installation of new equipment. Discussion follows. Member Cassady makes the motion to accept the budget from Selge Construction not to exceed \$25,000 to complete this project. Member Stiffler supports. A vote is taken: Three yeas and one nay. Motion carries. Administrator Forlenza will have discussion with Wastewater Attorney to investigate how to recoup some of the financial costs of this project.

### 2. CT Electric Station Transducer (C1)

A proposal is included in the packet from CT Electrical Services, Inc., regarding C1 Lift Station Transducer (Level Control). Member Stutsman makes the motion to accept the proposal not to exceed \$3,800.00. Member Cassady supports the motion. Discussion follows. A roll call votes is taken and all members present vote yea, no nays. **Motion Carries.**
